ADMINISTRATION ORDINANCE NO. 6- 2016

ADMINISTRATION BILL NO. 5 - 2016

INTRODUCED – MAY 10, 2016

ADOPTED BY COUNCIL – MAY 24, 2016

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LANCASTER, LANCASTER COUNTY, PENNSYLVANIA ESTABLISHING APPROPRIATIONS FOR \$247,500 OF FEMA DISASTER ASSISTANCE ANTICIPATED TO BE RECEIVED IN 2016; PROVIDING FOR THE REPEAL OF INCONSISTENT ORDINANCES; PROVIDING FOR THE SEVERABILITY OF THE ORDINANCE; AND PROVIDING THAT THE ORDINANCE SHALL TAKE EFFECT AS PROVIDED BY PENNSYLVANIA LAW.

WHEREAS, Section 1804 of the Third Class City Code, Act of June 23, 1931, P.L. 932, Number 317, reenacted and amended June 28, 1951, P.L. 662, Number 164, as amended, provides, inter alia, that, “No money shall be paid out of the city treasury except upon appropriation made according to law and on warrant drawn by the proper officer and pursuant thereof;” and

WHEREAS, Section 1804 of the Third Class City Code as set forth above further provides, inter alia, that, “The council may at any time by ordinance make supplemental appropriations for any lawful purpose from any funds on hand or estimated to be received within the fiscal year and not appropriated to any other purpose...;” and

WHEREAS, The City Council of the City of Lancaster anticipates the receipt of disaster assistance from the Federal Emergency Management Agency in the amount of \$247,500; and

WHEREAS, The City Council of the City of Lancaster desires to appropriate such \$247,500 to the Liquid Fuels Fund in advance of the receipt of these FEMA funds in order to provide funding for the 2016 street paving program funded by the Liquid Fuels Fund.

NOW, THEREFORE, BE AND IT IS HEREBY ORDAINED AND ENACTED by the City Council of the City of Lancaster, Lancaster County, Pennsylvania, as follows:

SECTION 1. The provisions of the background clauses set forth above be and hereby are incorporated herein.

SECTION 2. The City Council of the City of Lancaster hereby appropriates the \$247,500 anticipated to be received from FEMA in 2016 for the following purpose:

Transfer to the Liquid Fuels Fund - \$247,500

SECTION 3. The appropriate officers of the City of Lancaster be and hereby are authorized and directed to utilize the \$247,500 anticipated to be received from FEMA for the purposes set forth in SECTION 2 above.

SECTION 4. All ordinances or resolutions or parts of ordinances or resolutions insofar as they are inconsistent herewith are hereby repealed and rescinded.

SECTION 5. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, such invalidity shall not affect or impair any of the remaining provisions, sections, sentences, clauses or parts of this Ordinance; it being the intent of the City of Lancaster that the remainder of the Ordinance shall be and shall remain in full force and effect.

SECTION 6. This Ordinance shall become effective as provided by the laws of the Commonwealth of Pennsylvania.
