AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LANCASTER, LANCASTER COUNTY, PENNSYLVANIA AMENDING SECTION 249-27 OF THE CODE OF THE CITY OF LANCASTER TO CHANGE THE QUARTER ANNUAL SEWER RENTALS FOR CUSTOMERS WITHIN THE CITY LIMITS; PROVIDING FOR THE REPEAL OF INCONSISTENT ORDINANCES; PROVIDING FOR THE SEVERABILITY OF THE ORDINANCE; AND PROVIDING THAT THE ORDINANCE SHALL TAKE EFFECT ON THE FIRST DAY OF JANUARY 2017.

NOW, THEREFORE, BE AND IT IS HEREBY ORDAINED AND ENACTED by the City Council of the City of Lancaster, Lancaster County, Pennsylvania, as follows:

SECTION 1. The Code of the City of Lancaster, Chapter 249—Sewers, Article III—Sewer Rentals and Charges, Section 249-27—Schedule of Rates, be and hereby is amended to read as follows:

“Section 249-27. Schedule of rates.

The quarter-annual sewer rentals and charges shall be computed in accordance with the following schedules:

A. Consumption charges.

SECTION 2. All ordinances or resolutions or parts of ordinances or resolutions insofar as they are inconsistent herewith are hereby repealed and rescinded.

SECTION 3. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, such invalidity shall not affect or impair any of the remaining provisions, sections, sentences, clauses or parts of this Ordinance; it being the intent of the City of Lancaster that the remainder of the Ordinance shall be and shall remain in full force and effect.

SECTION 4. This Ordinance shall take effect the first day of January, 2017.
